Executive Summary for the Governance Council

On May 28, 2024, Los Angeles County (LAC) Charter SELPA received the SELPA Membership application on behalf of Explore Public Schools for the academic year 2024-2025. On October 6, 2021, the Orange County Board of Education approved the charter petition to establish Explore Public Schools, a countywide charter for a five-year term from July 1, 2022, through June 30, 2027.

SELPA Application Rationale:

The rationale for applying to join the LAC Charter SELPA is rooted in the school's commitment to providing exceptional education to all students, including those with special needs. As a new school scheduled to open in August 2024 with over 120 registrations already, the LEA recognizes the importance of partnering with a SELPA that can offer comprehensive professional development, training, and resources. By aligning with the LAC Charter SELPA, the charter school aims to enhance its capacity to effectively serve students with diverse learning needs. It believes that access to specialized training and resources will enable its educators to create inclusive and supportive environments where every student can thrive academically, socially, and emotionally. In joining LAC Charter SELPA, the school looks forward to collaborating with experienced professionals and leveraging expertise to meet the unique needs of students with disabilities, ensuring they receive the highest quality education and support.

School Overview:

Explore Academy is a TK through 12th-grade public county-wide charter school committed to closing the achievement gap for Orange County's largest and lowest-performing subgroups: Hispanics, English Learners, Socioeconomically Disadvantaged students, and students with disabilities.

Explore Academy provides students with the power of academic choice, allowing each student to create a unique educational pathway in preparation for a college future. At Explore Academy, their goal is for all students to master the Common Core State Standards ("CCSS"), Next Generation Science Standards ("NGSS"), History-Social Science Framework, English Language Development ("ELD") Standards, and the remaining State Content Standards (collectively, "State Standards").

Across the curriculum, students will engage in differentiated learning seminars and "flavors," coursework that is inherently elective in nature, standards-aligned, and tailored to a student's choice of study. The Charter School's concept of "flavors" is akin to the college model wherein students choose courses each term to fulfill a general course of study or an academic major. Although bounded by general content requirements, students can enroll in seminars with different themes (flavors) that most interest them, seminars that simultaneously address academic standards and foster student interest and engagement.

This student-centered approach to learning prepares students for long-term academic success by helping them gain content knowledge as well as cognitive and non-cognitive skills required for college and beyond. One of the keys to success of this program is the ability to offer differentiated classes, or seminars, each with their own theme, or "flavor" affording students a nearly endless number of course options. Each school site will have a significant number of courses available onsite. However, each student will also be able to enroll in courses (flavors) at other sites across the Orange County network, accessing them virtually from their home campus and while under the supervision of a

credentialed teacher. This sort of "cross-pollination" is a significant differentiator and uniquely requires multiple school sites across the County in order to function at its highest level. This form of curricular networking allows all students to benefit from teacher creativity and academic diversity while the school avoids developing pockets of opportunity that may exist for students at only one particular campus. It further allows for an increased cumulative level of academic choice for students by forgoing the requirement that each campus provide the same common flavor sets, thereby truly embracing each teacher's unique creativity while promoting the same academic opportunities for all students no matter where they reside.

Capacity Interview:

On June 10, 2024, a capacity interview was held to gather additional information about how the charter school plans to serve students with disabilities. LAC Charter SELPA interview panel members were Damali Thomas, Project Director; Krystal Walton, Coordinator; Alyssa Martinez, Financial Operations Consultant; Wendy Shmaeff, Director of Student Services – Village Charter Academy; Cindy Hall, Lead SES – Opportunities for Learning Santa Clarita, and Amber Cox, Special Education Coordinator – Lashon Academy and Lashon City. Charter school representatives in attendance were Laura Schlottman, Executive Director; Kelly Felton, Board President; Thomas Torkelson, Smart Management CEO; Calasia Carrion, Compliance Support; Isabel Perez, Office Manager; Michelle Perales, Special Projects Manager; Latonia Green, VP of Special Populations; Jeffrey Rothchild, COO, Management Company, and Roy Kim, COO, ICON School Management.

Based on the review of the application and capacity interview, Explore Public Schools meets the minimum standards pertaining to all required elements. As such, **LAC Charter SELPA does recommend approval of the Charter School** and that the Governance Council consider this recommendation for approval at its next meeting scheduled for June 20, 2023.

Executive Summary for the Governance Council

Mayacamas Countywide Middle School submitted a comprehensive application to the Los Angeles County Charter (LAC) SELPA on June 5, 2024. The LAC Charter SELPA reviewed the membership application on behalf of Mayacamas Countywide Middle School for academic year 2024-2025. Mayacamas Countywide Middle School desires to become its own LEA for special education purposes and agrees to operate a compliant program for students with disabilities. As such, they are seeking membership with the Los Angeles County Charter SELPA as required.

Mayacamas Countywide Middle School is a new charter school authorized by the Napa County Board of Education and will begin operation in the Fall of 2024. On May 7, 2024, the Board took action and approved the charter for a five-year term, July 1, 2024 through June 30, 2029.

SELPA Application Rationale:

Mayacamas Countywide Middle School is excited to apply to the LAC Charter SELPA. We believe our countywide benefit charter will be a good fit for the LAC Charter SELPA portfolio of schools, based upon our small initial size and innovative curriculum, and the fact that the foundation that will operate the Countywide has already established a very positive relationship with the SELPA. We are attracted to the fact that LAC Charter SELPA has a manageable number of charters in its membership, allowing for the establishment of healthy relationships between LAC Charter SELPA staff, the membership, and the member schools. Second, we trust our charter advisors immensely, and all have espoused the professionalism and helpfulness of the SELPA team, and we have experienced these traits firsthand with our first venture, Mayacamas Charter Middle School. In addition, we have found the staff to be extremely knowledgeable, with a strong command of the programs and the benefits provided to member schools. Given the responsiveness of previous communications with LAC Charter SELPA staff, their stellar reputations in the industry, and the smaller number of member schools in the portfolio, we feel we will be able to avail ourselves of the educational resources and assistance with less difficulty than in larger more impersonal Charter SELPAs. This will be especially helpful during our launch year as we navigate the rules, regulations, and processes. Finally, the LAC Charter SELPA has a strong reputation for providing its member schools with good service and vital resources in a challenging environment.

School Overview:

Mayacamas Countywide Middle School (Mayacamas) is a new, independent, countywide benefit charter middle school that will prepare grades 6-8 students for success in rigorous high schools, post-secondary education, and meaningful careers. Mayacamas is being founded by an engaged group of parents,

community leaders, and educators who seek to offer an alternative public education option for families in Napa Valley. Mayacamas' unique school model starts with the intentional recruitment and enrollment of a small, diverse student body. Students of different socio-economic status, race/ethnicity, home language, and life experiences will learn together with and from one another in an inclusive community celebrating the diversity of Napa County. The uniqueness of Mayacamas' Countywide opportunity is enhanced by the combination of innovative elements found together nowhere else in Napa County at the middle school level. These elements include:

- Academic mastery and application of California standards through New Tech Network's interdisciplinary project- and problem-based learning model.
- A highly personalized learning environment, including an Individual Learning Plan for every Student.
- A culture of social-emotional well-being and learning, with Advisory, Wayfarer, and monthly one-on-one meetings to review the Individual Learning Plan.
- College and career awareness: the Mayacamas College & Career Explorers Program.

These four unique elements are built on a foundation of effective teaching and family partnership. Effective teaching in the project-based environment is a critical part of our model. Our teachers will participate in extensive and comprehensive professional development and coaching in project-based learning instructional strategies and other topics to become experts in the delivery of every part of the Mayacamas program. Extensive summer sessions and "early release" time for two hours each Wednesday will allow teachers to hone their instructional skills, review student data, and collaborate with one another in planning differentiated curriculum and assessments.

Finally, parents, guardians, and families will be our partners in new ways in our collaborative school environment. Through volunteer participation in school life (never required but always appreciated), supporting the "Mayacamas College & Career Explorers Program," volunteering on the School Site Council or English Learner Advisory Committee, participating in parent education events, partnering with and simply communicating frequently with their child's advisor and teachers, parents will be an important part of their students' success at Mayacamas.

Capacity Interview:

The Los Angeles County Charter SELPA conducted the application review process, which included a capacity interview for membership consideration for the 2024-2025 school year. Below are the findings of the SELPA review:

BACKGROUND

The Individuals with Disabilities Education Act (IDEA) is a federal law that ensures free and appropriate public education to eligible children with disabilities. Within the IDEA, there are thirteen categories of disability that establish eligibilities for special education services.

One of these thirteen categories is classified as an 'emotional disturbance', which includes a condition exhibiting one or more of the following characteristics over a long period of time and to a marked degree that adversely affects a child's educational performance. Contained within the 'emotional disturbance' category are:

- An inability to learn that cannot be explained by intellectual, sensory, or health factors.
- An inability to build or maintain satisfactory interpersonal relationships with peers and teachers.
- Inappropriate types of behavior or feelings under normal circumstances.
- A general pervasive mood of unhappiness or depression.
- A tendency to develop physical symptoms or fears associated with personal or school problems.
- Schizophrenia.

States use the IDEA to serve children with qualifying disabilities, through evaluation and providing special education and other related services. IDEA also provides safeguards and specific rights to parents of children with disabilities, such as consent to services.

PROBLEM

The term 'emotional disturbance' in the federal IDEA law is an outdated and potentially offensive term, which is currently used to describe a large group of children with special needs in California's public education system. The IDEA requires parents to give consent before services can be provided to students, a process that can severely inhibited by offensive or confusing labels like 'emotional disturbance'. Numerous studies have shown that when a student's disabilities are correctly identified and the appropriate services are provided, that student has a much greater probability of succeeding academically. Labels like 'emotional disturbance' create barriers to identification that ultimately harm the academic success of California's students.

SOLUTION

AB 2173 allows the term 'emotional disability' to replace 'emotional disturbance' for educational purposes by stipulating that the two terms are substantively the same under California Education code and regulations.

By making this change, individuals in public education will now be able to use a much more appropriate term instead of 'emotional disturbance', without worrying about potential legal repercussions from using language that doesn't conform to existing California code or regulations.

Based on a review and evaluation of the *Explore Public Schools* SELPA Application, the June 10, 2024 LEA Capacity Interview, it is recommended the Governance Council vote to approve SELPA membership for the 2024-2025 school year to *Explore Public Schools* with the following conditions:

- 1. Signed Local Plan LEA Certification 5 by the Chief Executive Officer following SELPA Membership Approval on June 20, 2024, no later than June 25, 2024.
- 2. Receipt of a signed and executive SELPA Participants Agreement as early as the end of July but no later than the first day of school for the 2024-2025 school year.
- 3. Copy of credentials for all certificated staff that provide special education and related services no later than the first day of school for the 2024-2025 school year.
- 4. Submit two signed contracts from NPAs certified by the CDE to provide related services to students with disabilities no later than the first day of school for the 2024-2025 school year.
- 5. School administrator to attend new member orientation scheduled for August 12th from 9 a.m. to 12 p.m.
- School administrator and/or special education teacher to attend the SEIS Code Stack Conference scheduled for October 9th through 11th in Anaheim and submit evidence of attendance no later than November 1, 2024.
